



Telkom Quest Comic Con CPT Competition

Terms and Conditions

April - May 2026

1. Competition Rules:

- 1.1 This promotional competition ("**Competition**") is organized and run by Telkom SA SOC Ltd (Registration Number 1991/005476/30), a listed company duly registered in accordance with the laws of the Republic of South Africa, with its registered address at Telkom Park, The Hub, 61 Oak Avenue, Techno Park Highveld Centurion, Pretoria("Telkom") including its affiliates, partners, associations and agents ("**Organizers**").
- 1.2 By entering this Competition all Participants agree to abide by the following competition rules:

2. Competition Period:

- 2.1. The Competition commences from 09:00 am on 30 April 2026 and will continue until 18:00 pm on 3 May 2026 ("**Competition Period**").
- 2.2 The duration of the Competition may be extended or curtailed at the discretion of the Organizer. Any such amendment will be communicated via Telkom Social Media pages.

3. Who is eligible to win a prize:

- 3.1 Persons ("**Participants**") interested in entering the Competition must:
 - 3.1.1 be a natural person;
 - 3.1.2 be a South African citizen or a permanent resident with a valid identity document or passport and be in Cape Town, South Africa;
 - 3.1.3 be 18 (eighteen) years of age or older
 - 3.1.4 Must have participated in the Competition in accordance with clause 4 below during the Competition Period
- 3.2 Employees of the Telkom Group and their immediate families, advertising and promotion agencies, distribution partners, associated companies, and outlet owners and their immediate families and staff associated with this Competition are not allowed to enter the Competition.

4. To participate:

- 4.1 There is no purchase required to enter this Competition. Participation is free but does include purchase options. Standard data or network charges for using social media apply at your own cost.
- 4.2 To qualify, Participants must visit the Telkom VS Gaming stands at Comic Con Cape Town and obtain an official Telkom Quest Card.

4.3 Participants must complete at least 6 of the 10 listed activities on the Quest Card which include:

- Download the MyTelkom App
- Take a photo with a cosplayer, post and tag Telkom.
- Sign up for any of our participating deals (Samsung deals, Fibre offers, Telkom prepaid from R50, LTE offers)
- Sign up for VS Gameplay.
- Tap into mobile gaming with Samsung at the Telkom stand.
- Learn about creating a Telkom Smart Home.
- Find your clan and take a group photo, post and tag Telkom.
- Watch an eDiski match at the VS Gaming stage, take a selfie, post and tag Telkom.
- Play in the EAFC free to play competition.
- For 18-24 year olds, register for free on Plug'd.

4.4 Completed tasks must be verified by an official Telkom Promoter by presenting the Participant's mobile phone. Once verified, the Promoter will apply an official Telkom decal (sticker) to the Quest Card.

4.5 Participants must collect 6 decals and accurately capture their name and correct cellphone number with the Quest Giver to submit their entry.

5. Prizes

The prizes comprise of:

5.1 Daily Prizes:

5.1.1 Fifty (50) Takealot Vouchers to the value of Two Hundred and Fifty Rand (R250), will be awarded daily to the first 50 Participants who return a fully completed (6 decals) Quest Card.

5.2 Grand Prizes:

5.3 Three (3) grand prizes are available, namely:

- (a) one (1) Xbox console paired with a 3-month Xbox Game Studios Global voucher; and
 - (b) two (2) Honor X7B devices.
- Three (3) winners will be randomly selected from all qualifying participants who submitted valid entries during the Competition Period. Each selected winner will stand a chance to win one (1) of the grand prizes listed above. The draw will take place on 8 May and will be conducted under the supervision of, and certified by, an independent auditor in accordance with Regulation 11(5) of the Consumer Protection Act ("CPA"). Records of the draw will be retained for a period of three (3) years.

5.4 Telkom may substitute a prize or part of it for another of equal or greater value if the original is

unavailable.

- 5.5 All prizes (Takealot vouchers and Grand Prizes) will be distributed electronically or couriered starting from 8 May 2026. Grand prize winners will be announced on social media.

- 5.7 Winners will be notified via private message or phone call and must respond with their details **within 12 hours**, or the prize will be forfeited and awarded to a runner-up.
- 5.8 Winners may **decline marketing/publicity use** of their name, photo, or video.
- 5.9 A winner is not eligible to win another Telkom competition for **12 months**, including entries submitted via other social media accounts or another person's details.
